Notes to the price tables

* Lasting Power of Attorney registration fees

Registration fees of £92 for each power are not included and are payable directly to the Office of the Public Guardian. The two types are Property & Financial Affairs and Health & Welfare, and most people need both. Our brochure explains them.

** Probate Trust

The family name for three lifetime trusts: the **Estate Allocation Trust**, the **Investors Living Trust** and the **Investors Estate Allocation Trust**. Our brochure explains each one. **Every price in the tables is a total and includes the £1,000 legal drafting disbursement.** The Investors Estate Allocation Trust price covers your home and one further property; each additional property is £400 with Standard and £533 with Premium. None of these trusts reduces inheritance tax or protects assets from care fees: the assets remain part of your estate.

*** Inheritance tax planning

The **Tax Planning Report** sets out in writing where inheritance tax is likely to fall and the legitimate options for reducing it. It is a recommendation, not the implementation. The **Inheritance Tax Property Package** is a streamlined report, a discretionary trust and the associated land registry work. Each is charged in addition to your service level fee.

When you are ready to proceed

What happens next:

1. We start with a free review of your circumstances, with no obligation.
2. We confirm your instructions and your fee in writing before we start.
3. We prepare your documents and send them to you in draft.
4. When you are happy with the drafts, we arrange your signing appointment, four to six weeks from instruction.
5. After signing we check your documents, register them, and send you your originals.
